Privacy policy for this page

Data subjects: website users

In compliance with the Regulation (EU) 2016/679 (hereinafter referred to as "Regulation"), this page describes the methods of processing of the personal data of users accessing our website www.technacy.it.

The information below does not relate to other websites, web pages or online services accessible through any links available on our website but relating to resources external to the Data Controller's domain.

This privacy policy may be modified from time to time in the event of activation of new services or any updates of the laws. Therefore, we recommend to regularly access our website and check for any news. This page describes how the website is managed in relation to the processing of the personal data of its users. In compliance with art. 13 of the EU Regulation on the protection of natural persons with regard to the processing of personal data, this privacy policy is addressed to the users of the **TECHNACY S.R.L.**'s web services accessible through the website www.technacy.it. Any additional data processing operations are defined in the relevant privacy policy and cookie policy available on the homepage of the official website www.technacy.it.

This privacy policy applies only to **TECHNACY S.R.L.**'s website, thereby excluding any other websites accessible by the user through any link.

The Data Controller

A visit to this website may result in the processing of personal data relating to identified or identifiable persons.

Data Controller: according to the regulations in force, the Data Controller shall be **TECHNACY S.R.L.**, with registered office and operational headquarters in Via Molveno 5, 48015 Cervia (RA), Italy, tax code and VAT registration number 02399920392.

TECHNACY S.R.L. shall process the personal data specified in this page in order to carry out its activities. According to the data processing operations performed on this website, the legal bases for processing shall be consent, execution of a contract, fulfilment of a legal obligation or the pursuit of a legitimate interest.

Place of data processing

The data processing operations relating to the web services of this website shall be performed in Italy, shall be managed by the service provider Amazon Web Service and shall be arranged by *Pleiadi International Srl's* technical staff and other persons appointed by **TECHNACY S.R.L.** in the event of any updating or maintenance. No data resulting from any web service shall be disclosed. The personal data provided voluntarily by users submitting a contact request shall only be used to provide the requested service, including through external service providers.

Types of data processed and purposes for the processing

Navigation data

The computer systems and software procedures used to operate this website acquire, in the course of their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols.

Such data include IP addresses or domain names of the PCs and terminals used by users, URI/URL (Uniform Resource Identifiers/Locators) of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in reply, the numerical code indicating the status of the reply given by the server (successful, error, etc.) and other parameters concerning the user's operating system and computer environment.

Such data, which are required for using the web services, are also processed for the following purposes:

- Obtaining statistical information about the use of the services (most visited pages, number of visitors per time slot or day slot, geographical area of the requests, etc.);
- Checking the proper functioning of the services being offered.

Data provided by the user

The optional, express and voluntary sending of messages to **TECHNACY S.R.L.**'s contact addresses as well as the filling in and submission of the forms available on the website www.technacy.it shall imply the collection of the sender's contact data required to reply and all personal data included in the communications.

Specific privacy policies shall be published on the pages of the website www.technacy.it concerning the supply of specific services.

Cookies and other tracking systems

No cookies shall be used for user profiling.

(Not persistent) session cookies shall be used only to the extent strictly required to ensure safe and efficient navigation of the website. The storage of session cookies into the terminals or browsers shall be controlled by the user, if, at the end of HTTP sessions, information about the cookies shall remain stored in the service logs on the servers for the relevant period established by each third-party service provider. Any data collected through the cookies and how they are managed are fully described in the cookie policy.

Voluntary nature of the provision of data

Except for what specified about navigation data, the user shall be free to decide whether to provide the personal data required on the forms to request information to **TECHNACY S.R.L.** Whenever such data are requested, a specific privacy policy shall be provided and, if necessary, the user's consent shall be requested.

Data processing method

Personal data shall be processed using automated systems for the time strictly necessary to achieve the purposes for which data have been collected. Specific security measures shall be adopted to avoid the loss of data as well as any unlawful or incorrect use or unauthorised access. It is to note that, in order to provide a complete service, links to other websites managed by other data controllers are provided. We shall not be liable for any errors, contents, cookies, unlawful immoral contents, ads, banners or files not complying with the current regulations in force, nor for the compliance with the privacy regulations by any websites being referred to which we do not manage.

Recipients of the data

The recipients of the above-mentioned data collected when browsing the website are the following subjects, which, pursuant to art. 28 of the Regulation, have been appointed by **TECHNACY S.R.L.** as data processors.

- **Pleiadi International Srl** as provider of the web platform development and maintenance services;

The personal data collected shall be also processed by **TECHNACY S.R.L.**'s staff according to specific instructions on the purposes and methods of processing.

Transfer of data abroad

The Data Controller shall not transfer any personal data to any non-EU country. Should any transfer of data be necessary, the data subject shall be informed thereof in advance and appropriate safeguards shall be adopted for the transfer of data to the relevant recipients, which, as the case may be, might consist in the check of the existence of any adequacy decisions by the Commission with regard to the country of destination, the signing of standard contractual clauses or, in the event of the USA, the check of the accession to current international agreements. In the absence of such safeguards (in relation to art. 49 of the GDPR), it shall be checked whether any contract or any pre-contractual measures in favour of the data subject do exist or if the data subject has given his/her consent to the transfer of data.

Rights of the data subject

The data subject shall have the right to obtain from the Data Controller the erasure ("right to be forgotten"), updating, rectification, portability and restriction of processing of personal data concerning him or her as well as the right to object to processing of such data and, in general, to exercise all the rights under art. 15, 16, 17, 18, 19, 20, 21, 22, 23 of the GDPR, if applicable with respect to the purposes of data processing.

Regulation (EU) 2016/679: Art. 15, 16, 17, 18, 19, 20, 21, 22, 23

- 1. The data subject shall have the right to obtain confirmation as to whether or not personal data concerning him or her do exist, even if not yet registered, and to be provided such data in an intelligible form.
- 2. The data subject shall have the right to obtain information about:
- a. the origin of personal data;
- b. the purposes and methods of processing;
- c. the logic applied in the event of processing using electronic systems;
- d. the identification data of Data Controller, Data Processors and designated representative pursuant to art. 5, par. 2, of the GDPR;
- e. the entities or categories of entities to which the personal data may be disclosed or which may acquire such data as designated representative on the country's territory, Data Processors or entities in charge of data processing.
 - 3. The data subject shall have the right to obtain:
- a. the updating or rectification of data as well as to have incomplete personal data completed, if he/she wishes;
- b. the erasure or anonymisation of the data as well as the blocking of the data processed in violation of the law, including those that do not need to be kept in relation to the purposes for which data have been collected and then processed;
- c. the confirmation that the subjects to which the data have been communicated or disclosed have been informed of the operations under letter a) and b), including their content, unless this proves impossible or would involve a disproportionate effort with respect to the protected right;
- d. data portability.
 - 4. The data subject shall have the right to object, in whole or in part:
- a. to the processing of personal data concerning him or her for legitimate grounds, even though such data are relevant for the purpose for which they are collected;
- b. to the processing of personal data concerning him or her for the purposes of sending advertising materials or for direct marketing, market researches or commercial communications.

Right to lodge a complaint

If the data subject deems that the processing of personal data concerning him or her carried out through this website violates the Regulation, the data subject shall have the right to lodge a complaint with the Italian supervisory authority called "Garante per la protezione dei dati personali" pursuant to art. 77 of the Regulation or to take appropriate legal actions (art. 79 of the Regulation).
